Admission of qualified students is one strategy captured as a way of achieving this key result area. This policy is therefore a guide on the admission process. It sets the minimum qualifications required for entry into any programme on offer whilst taking into account the minimum criteria specified by the Commission for University Education.

## **1.0 Introduction**

Karatina University has established academic admission requirements for programmes on offer in line with the Commission of University Education (CUE), Universities Standards and Guidelines 2014. In addition, the University shall endeavour to keep abreast with national and international trends and emerging issues, maintain the quality standards set for each academic programme on offer at the University and meet the commitment of enhancing continuous improvement of the University management systems.

## **2.0 Goal**

The aim of the Admissions Policy is to provide guidelines for the admission of qualified applicants irrespective of social, ethnic, religious and economic orientation. In addition, the policy encourages applications by potential students and ensures impartial and objective assessment of each applicant on the basis of equal opportunities for all to access University education.

## **3.0 Objectives**

The objectives of the Admission Policy are to:

- 3.1 Standardize the admission procedures into an academic programme of the University
- 3.2 Set the minimum admission qualifications for each programme with requirement for individualized programmes
- 3.3 Outline the application process for an academic programme
- 3.4 Explain student admission and registration process
- 3.5 Give guidance on Credit Transfer

## **4.0 Justification**

Karatina University offers various academic programmes anchored in academic departments across five schools namely; School of Agriculture and Biotechnology, School of Business, School of Education and Social Sciences, School of Natural Resources and Environmental Studies and School of Pure and Applied Sciences. This Policy will ensure harmonization of admission procedures and will guide admission into programmes offered in the University. In addition, CUE Universities Standards



and Guidelines 2014, (PROG/STD/09), requires that minimum admission requirements be provided for every academic programme in line with nationally accepted admission requirements.

## 5.0 Policy Areas

The policy will address the following policy areas:

- 5.1 Application process for into Academic programme
- 5.2 Student Admission and Registration Process
- 5.3 Change of Programme
- 5.4 Minimum admission qualifications to various programmes
- 5.5 Credit Transfer

### 5.1 Application process for an Academic programme

Karatina University has both government and self-sponsored students and their application process into the academic programmes is explained in the sections below

### 5.2 Government Sponsored Students

- 5.2.1.1 Government Sponsored students are placed by Kenya Universities and Colleges Central Placement Services (KUCCPS) based on cut-off points for placement to degree programmes.
- 5.2.1.2 The University shall declare capacity to KUCCPS within the timelines given and the available resources in the University.
- 5.2.1.3 The University shall adhere to stipulated inter-university and programme transfer as recommended by KUCCPS.
- 5.2.1.4 The University shall admit KUCCPS placed students by issuing admission letters and other joining instructions (the acceptance form, personal details form, medical form and the fees structure).
- 5.2.1.5 Students shall become bonafide after going through and successfully completing the registration processes outlined from time to time.
- 5.2.1.6 The Academic Year shall normally start in September of every calendar year.

### **5.2.2 Privately Sponsored Students**

- 5.2.2.1 The potential applicant is required to select the degree programme of interest.
- 5.2.2.2 The potential applicant is expected to download the application form or collect one in any of the University campuses.
- 5.2.2.3 The applicant completes an application form and attaches copies of relevant academic certificate and transcripts or result slips, a copy of national identity card or birth certificate, and a receipt of the application fee.
- 5.2.2.4 The application documents are returned to the office of the Registrar (Academic Research Student Affairs) or dropped in admissions office or any of the University campuses for processing.

## **5.3 Student Admission and Registration Process**

The Policy presents the admission and registration process for both government and self-sponsored into the academic programmes as shown in 5.2.1 and 5.2.2

### **5.3.1 Government Sponsored Students**

- 5.3.1.1 The Deans of Schools will declare capacities in various programmes on offer and submit it to the Deputy Vice Chancellor (Academic Research Student Affairs) for tabling in the Committee of Deans and there after Senate.
- 5.3.1.2 The Senate approve University capacity declarations will be forwarded to KUCCPS for placement of students.
- 5.3.1.3 Upon receipt of a list of students admitted to Karatina University from KUCCPS, a nominal roll for each programme is generated
- 5.3.1.4 Admission letters of placed students are generated together with joining instructions (the acceptance form, personal details form, medical form and the fees structure).
- 5.3.1.5 The Registrar (Academic Research Student Affairs) convenes meeting(s) with representatives from Schools and relevant departments to prepare for registration and orientation of the new students.

5.3.1.6 Once the students report, the original result slips and fees payment documents are verified and national identity card or birth certificate used for identification before registration.

5.3.1.7 A fully registered will sign the nominal roll and a file opened for each individual student.

### **5.3.2 Privately Sponsored Students**

5.3.2.1 The Registrar (Academic Research Student Affairs) will prepare a draft advertisement of programmes on offer and circulate it to Deans of Schools for review and input before seeking financial approval from the Deputy Vice Chancellor (PFA).

5.3.2.2 The approved advertisement is done in the media.

5.3.2.3 Applications received are sorted by the respective Schools for consideration and recommendation for selection before submitting a summary and support documents for tabling in the Committee of Deans meeting for consideration and approval.

5.3.2.4 Admission letters of approved applicants are generated together with joining instructions (the acceptance form, personal details form, medical form and the fees structure).

5.3.2.5 Admission letters are issued to the successful applicants and the unsuccessful ones are notified.

5.3.2.6 During registration, the original academic certificates and transcript or result slips and fees payment documents are verified and national identity card or birth certificate used for identification before assigning a registration number.

5.3.2.7 A nominal roll will be prepared for signing by fully registered students and a file opened for each individual student.

5.3.2.8 Dean of school will ensure orientation of all new PSSP students.

5.3.2.9 Students seeking credit transfer will complete the relevant forms, attach their transcripts and submit them to their respective Heads of Department for



consideration and recommendations before submission to the Committee of Deans for consideration and approval.

### **5.3.3 Change of Programme**

- 5.3.3.1 Once students report to the University, they are given an opportunity to change to any other programme of choice (if need arise) on condition that students' qualifications allow and subject to availability of resources.
- 5.3.3.2 During students' orientation, students intending to change programmes within the University will be required to complete the relevant forms and submit them to their respective Deans of Schools within the specified duration.
- 5.3.3.3 The Deans of Schools will consider and submit their recommendations to Committee of Deans for consideration and approval.
- 5.3.3.4 The set programme admission criteria, cluster points and the available resources will be taken into considerations by the Committee of Deans before approval.
- 5.3.3.5 The decision of the Committee of Deans will be communicated to the respective students and registration facilitated for the successful students to the new programmes.

## **5.4 Minimum admission qualifications to various programmes**

The minimum admission qualification in the University shall be:

- 5.4.1.1 Doctorate programme: - Relevant academic master's degree holders
- 5.4.1.2 Master's programme
  - a) Relevant academic bachelor's degree holders:
    - i. Upper second class honors or a cumulative Grade Point Average (GPA) of 3.00 on a scale of 4.00;
    - ii. Lower second class honors or a cumulative Grade Point Average (GPA) of 2.50 on a scale of 4.00 with additional relevant training, evidence of research capability either through research, paper presentations or peer reviewed publications and relevant working experience.
  - b) Relevant postgraduate diploma.
- 5.4.1.3 Postgraduate diploma programme: Undergraduate degree holder



- 5.4.1.4 Undergraduate programmes:
- a) C+ for Kenya Certificate of Secondary Education (KCSE) holders or its equivalent as determined by the Kenya National Examination Council (KNEC);
  - b) KNEC diploma or its equivalent.
- 5.4.1.5 The specific minimum admission qualifications to various doctorate, masters, postgraduate diploma, undergraduate, diploma programmes and certificate programmes are as indicated in the Annex I.

## 5.5 Credit Transfer

- 5.5.1 Credits transfer may be awarded for undergraduate programmes by considering course content, duration and intensity of the courses in comparison to the University Programmes.
- 5.5.2 A maximum of fifteen (15) courses may be allowed for credit transfer from another similar and/or comparable degree programme as long as the score in each course is equal to or better than B for the respective course.
- 5.5.3 A student must study in the University for at least half of the duration of the programme.
- 5.5.4 Only a maximum 49% of the core course units for similar programmes shall be transferred.
- 5.5.5 Where applicable, teaching practice or practicum or industrial attachment or research work must be undertaken at Karatina University.
- 5.5.6 When reviewing a course for content, a two third yardstick of the material of a similar course shall be used judged to be comparability.
- 5.5.7 Courses which must contain very specific topics to prepare students for a particular function or for further study may be reviewed by the faculty of their discipline for comparability determination outside of the two third guideline.
- 5.5.8 Credit shall be transferred on a course by course basis.

## 5.6 Monitoring and Evaluation

Continuous monitoring and evaluation of admission shall be the responsibility of Heads of Departments, Deans of Schools Directorate of Quality Assurance and Registrar Academic Affairs.

## 5.7 Review of the Policy

This policy will be reviewed from time to time as may be deemed necessary by Senate.

## **ANNEX I: Specific minimum admission qualifications to various programmes**

### **5.1 SCHOOL OF AGRICULTURE AND BIOTECHNOLOGY**

#### **5.1.1 PhD in Soil Sciences**

Holder of a Masters degree in Soil Sciences and one publication OR Holder of other qualifications considered by Karatina University Senate as equivalent of a Masters degree in the relevant field.

#### **5.1.2 PhD in Plant Pathology**

Holder of a Masters degree in Plant Pathology and one publication OR Holder of other qualifications considered by Karatina University Senate as equivalent of a Masters degree in the relevant field.

#### **5.1.3 Master of Science in Horticultural Sciences**

Upper Second class honours degree and above in Horticulture/Agriculture OR Second class lower degree in Horticulture/Agriculture with at least two years relevant experience or one research publications or a relevant Postgraduate Diploma OR a pass degree in either of the above disciplines with relevant experience of NOT less than 5 years earned after the degree and at least one publication.

#### **5.1.4 Master of Science in Crop Protection**

Upper Second class honours degree and above in Agriculture OR Second class lower degree in Agriculture with at least two years relevant experience or one research publications or a relevant Postgraduate Diploma OR a pass degree in either of the above disciplines with relevant experience of NOT less than 5 years earned after the degree and at least one publication.

#### **5.1.5 Master of Science in Weed Science**

Upper Second class honours degree and above in Agriculture OR Second class lower degree in Agriculture with at least two years relevant experience or one research publications or a relevant Postgraduate Diploma OR a pass degree in either of the above disciplines with relevant experience of NOT less than 5 years earned after the degree and at least one publication.

#### **5.1.6 Master of Science in Soil Science**

Upper Second class honours degree and above in Soil Science OR Second class lower degree in Soil Science with at least two years relevant experience or one research publications or a relevant Postgraduate Diploma OR a pass degree in either of the above disciplines with relevant experience of NOT less than 5 years earned after the degree and at least one publication.

#### **5.1.7 Postgraduate Diploma in Tea Science and Management**



Bachelor of Science Degree in Horticulture/Agriculture and any other related discipline from a recognized institution.

**5.1.8 Bachelor of Science in Food Science and Nutrition**

Minimum mean grade of C+ (Plus) at KCSE with a C in Mathematics and C+ in any two of the following subjects: Biology, Chemistry, Agriculture, or Home science OR 2 principal passes and one subsidiary pass in above subjects at 'A' level OR holders of a recognized Diploma in Agriculture or related discipline from a recognized institution.

**5.1.9 Bachelor of Science in Human Nutrition and Dietetics**

Minimum mean grade of C+ (Plus) at KCSE with a C in Mathematics and C+ in any two of the following subjects: Biology, Chemistry, Agriculture, or Home science OR 2 principal passes and one subsidiary pass in above subjects at 'A' level OR holders of a recognized Diploma in Agriculture or related discipline from a recognized institution.

**5.1.10 Bachelor of Science in Horticultural Science and Management**

Minimum mean grade of C+ (Plus) at KCSE with a C in Mathematics and C+ in any two of the following subjects: Biology, Chemistry, Agriculture, or Home science OR 2 principal passes and one subsidiary pass in above subjects at 'A' level OR holders of a recognized Diploma in Agriculture or related discipline from a recognized institution.

**5.1.11 Bachelor of Science in Agricultural Extension Education**

Minimum mean grade of C+ (Plus) at KCSE with a C in Mathematics and C+ in any two of the following subjects: Biology, Chemistry or Agriculture, OR 2 principal passes and one subsidiary pass in above subjects at 'A' level OR holders of a recognized Diploma in Agriculture or related discipline from a recognized institution.

**5.1.12 Bachelor of Science in Agricultural Resource Economics and Management**

Minimum mean grade of C+ (Plus) at KCSE with a C in Mathematics and C+ in any two of the following subjects: Biology, Chemistry or Agriculture OR 2 principal passes and one subsidiary pass in above subjects at 'A' level OR holders of a recognized Diploma in Agriculture or related discipline from a recognized institution.

**5.1.13 Diploma in Horticulture**

Minimum mean grade of C- (Minus) at KSCE with D+ in Mathematics or Physics, C- in any two of the following science subjects: Agriculture, Biology, Chemistry, Biological Sciences, Physical Science, Home Science and Geography OR O-Level certificate with at least Division III with following grades: Pass in Physics or Mathematics and any two of the following subjects: Agriculture, Biology, Chemistry, Biological Sciences, Physical Science, Home Science and Geography; OR Two year general Certificate in Agriculture or related fields.

**5.1.14 Diploma in Agriculture**

Minimum mean grade of C- (Minus) at KSCE with D+ in Mathematics or Physics, C- in any two of the following science subjects: Agriculture, Biology, Chemistry, Biological

Sciences, Physical Science, Home Science and Geography OR O-Level certificate with at least Division III with following grades: Pass in Physics or Mathematics and any two of the following subjects: Agriculture, Biology, Chemistry, Biological Sciences, Physical Science, Home Science and Geography; OR Two year general Certificate in Agriculture or related fields.

**5.1.15 Diploma in Tea Husbandry and Management**

Minimum mean grade of C- (Minus) at KSCE with D+ in Mathematics or Physics, C- in any two of the following science subjects: Agriculture, Biology, Chemistry, Biological Sciences, Physical Science, Home Science and Geography OR O-Level certificate with at least Division III with following grades: Pass in Physics or Mathematics and any two of the following subjects: Agriculture, Biology, Chemistry, Biological Sciences, Physical Science, Home Science and Geography; OR Two year general Certificate in Agriculture or related fields.

**5.1.16 Diploma in Tea Trade and Economics**

Minimum mean grade of C- (Minus) at KSCE with D+ in Mathematics or Physics, C- in any two of the following science subjects: Agriculture, Biology, Chemistry, Biological Sciences, Physical Science, Home Science and Geography OR O-Level certificate with at least Division III with following grades: Pass in Physics or Mathematics and any two of the following subjects: Agriculture, Biology, Chemistry, Biological Sciences, Physical Science, Home Science and Geography; OR Two year general Certificate in Agriculture or related fields.

**5.1.17 Diploma in Tea Processing and Quality Assurance**

Minimum mean grade of C- (Minus) at KSCE with D+ in Mathematics or Physics, C- in any two of the following science subjects: Agriculture, Biology, Chemistry, Biological Sciences, Physical Science, Home Science and Geography OR O-Level certificate with at least Division III with following grades: Pass in Physics or Mathematics and any two of the following subjects: Agriculture, Biology, Chemistry, Biological Sciences, Physical Science, Home Science and Geography; OR Two year general Certificate in Agriculture or related fields.

**5.1.18 Certificate in Tea Economics and Trade**

Minimum mean grade of D + (Plus) at KCSE OR Div III at KCE

**5.1.19 Certificate in Tea Husbandry and Management**

Minimum mean grade of D + (Plus) at KCSE OR Div III at KCE

**5.1.20 Certificate in Tea Post-harvest Handling and Quality Assurance**

Minimum mean grade of D + (Plus) at KCSE OR Div III at KCE

**5.1.21 Certificate in Tea Processing Operation and Engineering**

Minimum mean grade of D + (Plus) at KCSE OR Div III at KCE



## **5.2 SCHOOL OF BUSINESS**

### **5.2.1 PhD in Business Management**

Holder of a master degree in Business Management and one publication OR Holder of other qualifications considered by Karatina University Senate as equivalent of a master's degree in the relevant field.

### **5.2.2 PhD in Entrepreneurship**

Holder of a master degree in Entrepreneurship and one publication OR Holder of other qualifications considered by Karatina University Senate as equivalent of a master's degree in the relevant field.

### **5.2.3 PhD in Human Resource Development**

Holder of a master degree in Human Resource Management and one publication OR Holder of other qualifications considered by Karatina University Senate as equivalent of a master's degree in the relevant field.

### **5.2.4 PhD in Communication and Public Relations**

Holder of a master degree in Communication and Public Relations and one publication OR Holder of other qualifications considered by Karatina University Senate as equivalent of a master's degree in the relevant field.

### **5.2.5 Masters of Business Management**

Upper Second class honours degree and above in Business/Economics/Administration/Commerce OR Second class lower degree in Business, Economics, Administration or Commerce with at least two years relevant experience or one research publications or a relevant Postgraduate Diploma

### **5.2.6 Master of Human Resources Management**

Upper Second class honours degree and above in Human Resource Management OR Second class lower degree in Human Resource Management with at least two years relevant experience or one research publications or a relevant Postgraduate.

### **5.2.7 Master of Science in Entrepreneurship**

Upper Second class honours degree and above in Entrepreneurship OR Second class lower degree in Entrepreneurship with at least two years relevant experience or one research publications or a relevant Postgraduate Diploma.

### **5.2.8 Master of Science in Hotel and Hospitality Management**

Upper Second class honours degree and above in Hotel and Hospitality Management OR Second class lower degree in Hotel and Hospitality Management with at least two years relevant experience or one research publications or a relevant Postgraduate Diploma.

### **5.2.9 Master of Science in Communication and Public Relations**

Upper Second class honours degree and above in Communication and Public Relations  
OR Second class lower degree in Communication and Public Relations with at least two  
years relevant experience or one research publications or a relevant Postgraduate  
Diploma.

**5.2.10 Executive Masters in Business Management**

Applicants must have a working experience of at least (5) years at a managerial level  
PLUS - A first degree in any discipline from a recognized University OR CPA (K) / CPS  
(K) Certificate OR Higher National Diploma in Business Studies.

**5.2.11 Bachelor of Business Management**

Minimum mean grade of C+ (Plus) at KCSE and at least a C in English and C in  
Mathematics or Commerce or Business Studies or Economics or Accounting OR 2  
principal passes and one subsidiary pass at 'A' level OR Diploma in business related  
field from a recognized institution.

**5.2.12 Bachelor of Tourism Management**

Minimum mean grade of C+ (Plus) at KCSE and at least a C in English or  
Kiswahili/Kiswahili OR 2 principal passes at 'A' Level plus at least a pass in  
Mathematics and English at 'O' level OR Diploma in Tourism or Tour Guiding from a  
recognized institution.

**5.2.13 Bachelor of Human Resources Management**

Minimum mean grade of C+ (Plus) at KCSE and at least C in Mathematics and C in  
English OR 2 principal passes at 'A' Level plus at least a pass in Mathematics and  
English/Kiswahili at 'O' level OR A Diploma in Human Resource Management from a  
recognized institution.

**5.2.14 Bachelor of Project Planning and Management**

Minimum mean grade of C+ (Plus) at KCSE and at least a C in English and C in  
Mathematics or Commerce or Business Studies or Economics or Accounting OR 2  
principal passes and one subsidiary pass at 'A' level OR Diploma in Project Planning  
and Management from a recognized institution.

**5.2.15 Bachelor of Science in Entrepreneurship**

Minimum mean grade of C+ (Plus) at KCSE and at least C in Mathematics or in  
Accounting /Commerce /Business Studies and C in English/Kiswahili OR 2 Principal  
passes and a subsidiary pass at 'A' Level OR a Diploma in Entrepreneurship from a  
recognized institution.

**5.2.16 Bachelor of Hotel and Hospitality Management**



Minimum mean grade of C+ (Plus) at KCSE and at least C in English or Kiswahili OR 2 Principal passes at "A" level plus at least pass in Mathematics and English at "O" level OR A Diploma in Hotel and Hospitality Management from a recognized institution.

**5.2.17 Bachelor of Economics**

Minimum mean grade of C+ (Plus) at KCSE and at least a C in English and C in Mathematics or Commerce or Business Studies or Economics or Accounting OR 2 principal passes and one subsidiary pass at 'A' level OR Diploma in Economic related field from a recognized institution.

**5.2.18 Bachelor of Communication and Public Relations**

Minimum mean grade of C+ (Plus) at KCSE and at least C+ (Plus) in English and C+ (Plus) in Kiswahili OR Diploma in Human Resource Management/Journalism/Public Relations /Information Technology from a recognized institution.

**5.2.19 Bachelor of Procurement and Supply Chain Management**

Minimum mean grade of C+ (Plus) at KCSE and at least a C in English and C in Mathematics or Commerce or Business Studies or Economics or Accounting OR 2 principal passes and one subsidiary pass at 'A' level OR Diploma in Procurement and Supply Chain Management from a recognized institution.

**5.2.20 Diploma in Business Management**

Minimum mean grade of C- (Minus) at KCSE level with at least C- in English/ Kiswahili, D+ Mathematics or Accounting, Commerce, Economic or Business Studies OR 'A' level Qualification with at least a subsidiary pass OR Certificate awarded by a recognized exam body or institution of higher learning.

**5.2.21 Diploma in Procurement & Supply Chain Management**

Minimum mean grade of C- (Minus) at KCSE level with at least C- in English/ Kiswahili, D+ Mathematics or Accounting, Commerce, Economic or Business Studies OR 'A' level Qualification with at least a subsidiary pass OR Certificate awarded by a recognized exam body or institution of higher learning.

**5.2.22 Diploma in Tourism Management**
